

HIDDEN SPRING RANCH
BREEDING CONTRACT

This contract for the breeding season of 2007 is made to and entered into by and between

Susan Champlin,

hereinafter referred to as Stallion Owner, and

hereinafter referred to as Mare Owner. WHEREAS, the Mare Owner agrees to breed the mare

breed/type and registration number

to the stallion

TUCK N RUN, AQHA 2969579,

for the fee of

\$ 1,500.00,

subject to the following conditions:

1. The Stallion Owner hereby reserves one season's booking to said stallion for said mare upon payment of the \$ 250.00 booking fee, which is not refundable and is to accompany this contract. This amount shall be applied against the stallion service fee.
2. The mare owner shall pay the board rate per day under which conditions said mare is to be boarded by Stallion Owner: \$ 10 per day dry or \$ 12 per day wet (nursing).
3. The mare shall be in healthy and sound breeding condition, free from infectious, contagious or transmissible disease. A photo copy of registration papers, health certificate, plus a health, worming and vaccination schedule must accompany the mare. Stallion Owner has the right to refuse mare if not in proper condition.
4. Stallion Owner will exercise care and judgement in care and supervision for mare and/or foal. Stallion Owner's veterinarian will examine mare for normal breeding conditions and will administer medical care as deemed necessary for the health and safety of the mare and/or foal. All veterinarian expenses will be paid by Mare Owner.
5. Both parties agree that the Stallion Owner and any person associated with Stallion Owner is not liable for death, sickness and/or accident caused to the mare and/or foal, and, that the Mare owner is not responsible for death, sickness, and/or accident caused to the stallion.

6. Stallion Owner agrees to diligently try to settle mare; however if mare fails to settle, for any reason, mare Owner will hold Stallion Owner blameless. Mare Owner agrees to Stallion Owner ample opportunity to settle mare.

7. The contract contains a "Live Foal Guarantee". A live foal is described as a newborn foal which stands and nurses without assistance. If a foal is born dead, there are return privileges only if Stallion Owner is notified within 10 days and receives a veterinarian's statement confirming death. It is agreed that should mare miscarry, abort or prove barren after leaving Stallion Owner's premises, Mare Owner has the privilege to return her for breeding during the current breeding season, February through June 2007, or the following breeding season, February through June 2008.

8. This contract is not transferable or assignable. In the event the mare is sold or otherwise disposed of prior to the birth of the foal, the "Live Foal Guarantee" will no longer be valid.

9. Should the above named stallion die, or be sold by the owner, or become unfit for service, the booking fee will be refunded, thereby canceling this entire contract.

10. None of the above mentioned fees shall be refundable. The Mare Owner agrees to pay the balance of the breeding fee (\$1,250.00), plus all board board fees, all veterinarian fees, and all other expenses incurred on behalf of said mare and/or foal **before** said mare leaves the Stallion Owner's premises. Unpaid accounts shall be charged 1 1/2% interest on the unpaid balance (annual percentage rate 18%). A Stallion Service Certificate will be issued **only** upon payment of all outstanding charges.

11. If the Mare Owner fails to pay all fees when due, he shall be in default of this contract. Mare Owner is responsible for all reasonable attorney fees and court costs necessary to collect this contract.

BY SIGNING THIS DOCUMENT I AGREE THAT I HAVE READ THE ENTIRE DOCUMENT, UNDERSTOOD ITS TERMS, AND AGREE TO THEM.
